

1. 下記URLから応募フォームにアクセスし、「Apply」とクリックしてください。

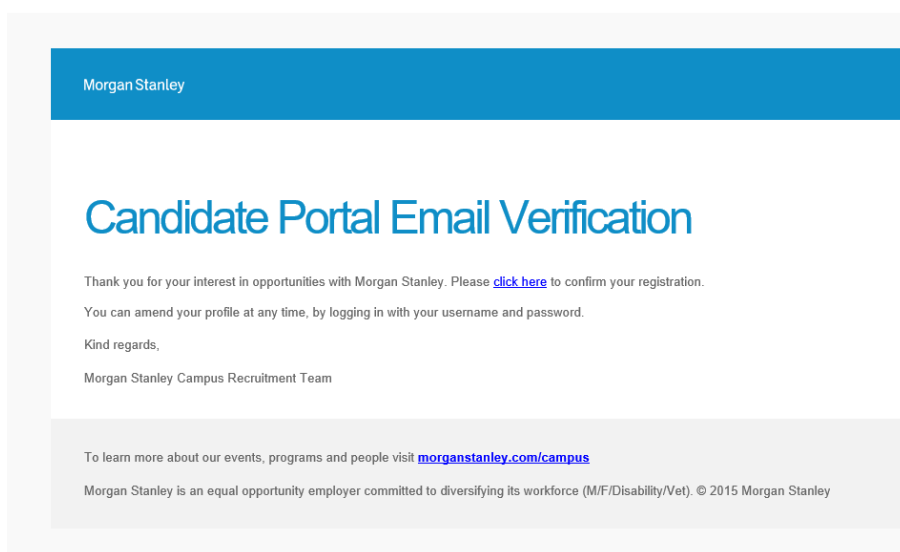
